SIXTY-MONTH TIME LIMITS COMPLIANCE FOR CUSTOMERS

PROGRAM AFFECTED: TEMPORARY CASH ASSITANCE (TCA)

SUMMARY

In May 1999, a Supreme Court decision on a California case concluded that residency requirements violated the individual's right to travel. As a result of this decision, Maryland rescinded the residency requirements for families moving from other states. However, the local departments must continue to apply the sixty-month time limit on all cases. The time limit includes any month that TANF benefits were received from other states. Case managers must take the following steps to ensure proper application of this policy.

ACTION REQUIRED

- Explain the 60-month time limit to the customer.
- Ask customers if they have been on assistance in other states.
- Contact the prior states to verify the case status of Temporary Assistance to Needy Families (TANF) and determine the number of months TANF benefits were received.

- Have the supervisor adjust the time limit counter on CARES to reflect the number of months the customer received TANF benefits from the other states. The supervisor should make the adjustment before the case is finalized.
- For your convenience, we have attached a TANF Information List that includes telephone numbers and other TANF Information for each state

CARES PROCEDURES

- Case managers must interview and process the case.
- In processing, enter the customer's previous out-of-state addresses on the "Previous household Address" PREV screen by entering a "Y" in the "Previous Address in Last 2 Years" field on the ADDR screen. Also enter dates of residence at the Out-of-state address on the "from to" fields on the PREV screen for each address listed.
- Once the case has been processed, the Supervisor must adjust the time limit counter (T LE) by adding to any existing count the number of months the Temporary Assistance to Needy Families (TANF) benefits were received in the prior states in the "TCA Ctr" field on the DEM2 01 screen. The supervisor should count all applicable months when adjusting the counter.
- The case must then be finalized.
