EXCLUDED INCOME FOR TEMPORARY CENSUS EMPLOYEES

PROGRAM AFFECTED: TCA, FOOD STAMPS (FS), MEDICAL ASSISTANCE (MA)

AND POC

SUMMARY:

Action Transmittal FIA/OPRS # 00-31 dated 12/15/99 gave instructions to local departments to exclude the earnings for TCA and POC customers who are employed for 90 days or less as short-term, temporary enumerators during the year 2000. Census employment was considered countable earned income when determining benefits for food stamps or Medical Assistance.

The Food and Nutrition Service (FNS) recently offered States the opportunity to participate in a demonstration project under which the earnings of certain temporary census workers are excluded as income for Food Stamp Program purposes. Maryland has chosen to participate. Medical Assistance has agreed to match the Food Stamp income exclusion. We are repealing the current regulation and submitting a new emergency regulation to match disregarded Census earnings for TCA and POC to the other programs.

Therefore, <u>DO NOT COUNT</u> the earnings for TCA, POC, Food Stamp and Medical Assistance customers who are temporarily employed by the Census for <u>180 days or less</u> during the year 2000. All other Census employment is considered countable earned income for all programs.

ACTION REQUIRED:

Beginning April 1, 2000 with applications and recertifications, **DISREGARD** the earnings of TCA, POC, FS and MA customers, hired as temporary employees for Census 2000 for 180 days or less during the year 2000.

SPECIAL NOTE:

- □ Temporary Cash Assistance Short-term temporary Census earnings for enumerators and canvassers hired for up to 90 days was disregarded beginning January 1, 2000 (AT #00-31). When customers whose Census income could have been excluded for January, February and/or March are discovered, restore benefits to the customers for those months.
- Purchase of Care Short-term temporary Census earnings for enumerators and canvassers hired for up to 90 days was disregarded beginning January 1, 2000 (AT #00-31). When customers whose Census income could have been excluded for January, February and/or March are discovered, restore benefits to the customers for those months.
- Food Stamps Census income for Food Stamps may be excluded beginning February 1, 2000. When customers whose Census income could have been excluded for February and/or March are discovered, restore benefits to the customers for those months.
- Medical Assistance Census income for Medical Assistance may be excluded beginning January 1, 2000. When customers whose Census income could have been excluded for January, February and/or March are discovered, restore benefits to the customers for those months.

ACTION DUE: Effective April 1, 2000

NARRATE ALL CASE ACTIVITY CAREFULLY:

Case managers are to document the type (full-time, part-time and title) of Census employment on the narration screen (NARR) for all programs. Local departments must ensure that narration of case activity is clear, concise, and complete according to the action taken. Good narration also supports the local department decision in the event of a fair hearing or selection for Quality Control review.

CARES PROCEDURES FOR INCOME EARNED BY TEMPORARY CENSUS EMPLOYEES

TCA/Food Stamps/Medical Assistance Cases

- On the ERN1 screen
 - Enter the employers' name and address.
 - In the Type field, enter VI (Vista Volunteer income is not counted for any program).
 - Complete all required fields.
- On the ERN2 screen
 - Complete all required fields
 - Narrate all actions.

NOTE: The valid value of VI is used as a work around to exclude earnings for customers who are temporarily employed by the Census for 180 days or less during the year 2000.
