RE: CHANGE IN ELECTRONIC BENEFIT TRANSFER (EBT) ISSUANCE

PROGRAM AFFECTED: FOOD STAMP PROGRAM

SUMMARY

Currently, the State issues food stamp regular monthly benefits over a five-day period according to alphabetical listing of the head of household's last name.

The large volume of food stamps issued over the five-day period creates hardships on retailers and on customers waiting in long lines. Because of this, the Maryland Retailer's Association met with DHR and requested a change in the EBT food stamps issuance schedule.

To be more responsive to the community, effective November 2003, we will issue food stamp benefits over a 10-day period. Regular food stamp issuance will begin on the sixth of the month and go through the 15th. The attached chart shows the new issuance dates. To minimize the impact on customers, issuance dates were arranged so that no household must wait more than five additional days for their November benefits. There is no change to the issuance of cash assistance.

Households will receive the attached notice to tell them of the change in issuance dates. Although no local department action is required with this change, we anticipate customer phone calls inquiring about benefit availability. Please advise any customers who call of the change and apologize for any inconvenience to them.

IMPORTANT FOOD STAMP NOTICE

The day your food stamps are put in your Independence Card account may change.

Beginning in November, food stamp benefits will be issued on a new 10-day schedule. No one's food stamps will be later than five days from the day of the month the food stamps were previously available. Here is the new schedule:

Food Stamp Schedule Effective November 2003

Remember: You do not have to use all of your food stamps on the day you receive them. You can use them to shop for food over the entire month.

You also do not have to use all of your food stamps in the month you get them. You can use them to buy food the next month.
