RE: SOCIAL SECURITY (RSDI) AND SSI COST-OF-LIVING INCREASE

AND RELATED INCREASES

PROGRAMS AFFECTED: MEDICAL ASSISTANCE

Summary:

Historically, Social Security Retirement, Survivors, and Disability Insurance (RSDI) and Supplemental Security Income (SSI) benefit payments have increased each year. This is usually true for Railroad Retirement and Veterans Benefits also. The mass change process to take these changes into account for Medical Assistance purposes is described in this transmittal. Action transmittal 08-20 covers the effect of the Social Security cost-of-living adjustment on cash assistance and food stamps.

Action Required:

Effective January 2008, Social Security (RSDI) and SSI benefits will increase by 2.3% and Railroad Retirement and Veterans Benefits will be adjusted by the same percentage. Local Departments need to take these changes into account in all affected programs according to the procedures outlined on the following pages.

NOTE: Count the increase for all cases beginning with January 2008 benefits. A mass change took place on December 8, 2007 to update the RSDI, SSI, Railroad Retirement and Veterans Benefits for ongoing cases effective January 1, 2008.

II. Increase in Railroad Retirement Benefits

Railroad Retirement (RR) benefits was also adjusted in the mass modification for January 2008.

III. <u>Increase in Veterans Benefits</u>

The cost-of-living increase in the VA pension program will also be 2.3% effective January 2008. Veterans Benefits was also be adjusted in the mass modification for January 2008.

IV. Long Term Care Medical Assistance Cases

The mass change adjusted the available income and sent a notice to the customer and facility.

V. Community Medical Assistance Cases

Adjustments in these cases were done by the mass change. The changes will be effective in all active cases, including those preserved for Spenddown.

VI. Coverage for Certain Former SSI Recipients under the Pickle Amendment

The annual review for potential Pickle eligible persons is to be conducted as noted in Action Transmittal #00-12.

VII. CARES

On December 8, 2007, the Social Security and SSI cost-of-living income adjustments (COLA) will be made to CARES Assistance Units (AUs) in active or spend-down status. This process, referred to as Mass Modification, causes all assistance units to be put through batch eligibility. Batch eligibility examines each AU for all eligibility factors and determines program type, AU status and benefit level. Case managers will receive an alert (#224 Grant Changed in Batch) for any AU with a change in status or benefit level. Also produced, if applicable, are adverse action notices.

CARES will also update the SSA and SSI income fields on cases that are in an active no pay status, providing such income is present on the UINC (unearned income) screen. However, eligibility will not be calculated or notices produced until the case is reactivated. Cases in a pend status with SSI or SSA income should be reviewed so that the income is correctly reflected for January.
