BACKGROUND INFORMATION:

Eligibility for MA extensions after the first six months is based on the customer's earned income falling below 185% of the federal poverty level. The federal poverty level is adjusted anually in February.

ACTION REQUIRED:

The income guidelines are to be used to determine eligibility for MA extensions when the 6 month and 9 month quarterly reports are received from the customers. Earned income less verified child care must be below 185% of the poverty level. Additionally, the 1996 MA-PWC, QMB amd SLMB income standards are included. Maryland Kids Count also uses the 185% income level. (DHMH is distributing the PWC Manual Release. The QMB/SLMB standards were released in DHMH Manual Release MR-72.)
