Conversion for Prince George's County will begin at the close of business on Thursday, January 30, 1997. During conversion, the CIS/CARES system will not be available on Friday, January 31 and Monday, February 3, 1997.

In Prince George's County ONLY, AIMS/AMF cut-off is close of business Wednesday, January 29, 1997. Therefore, the emergency procedure will be effective in Prince George's County January 30, 31, and February 3. Do not transfer any cases to Prince George's County from January 24 until February 4, 1997.

In order to ensure that the emergency needs of our customers are met, certain steps must be taken. First, local departments must make every effort to convince a vendor to accept delayed payment. Vendors will usually agree to this if assured by the LDSS that payment is forthcoming.

Expedited Food Stamps and emergency assistance situations not amenable to an informal solution require more work to resolve. In these situations, the CIS/CARES jurisdiction will need to have an assigned AIMS jurisdiction issue the necessary benefits as follows:

#### Α. EXPEDITED FOOD STAMPS

The designated AIMS county will receive the written request via FAX to create an AIMS case for the CARES county customer. The customer will be trained and have an EBT card issued by the originating CARES department in the normal The AIMS county will create a case using their case numbering sequence just as they would for one of their own cases. The AIMS county will do an AIFO or AIFI/Administrative terminal authorization as they would normally.
