Settlement Judge, Mediator.

At the Review Commission, a consistent, significant portion of my assigned docket, was to serve as a Settlement Judge, Mediator. I conducted numerous in-person and virtual voluntary and mandatory settlement conferences to resolve complex, significant cases pending before the Review Commission, concerning workplace safety and health issues. Cases before the Commission concern employer contests of federal OSHA citations. Settlement proceedings are conducted pursuant to the Commission Procedural Rules, Subpart H, Settlement Part, 29 C.F.R. §2200.120.

This experience included settlement conferences conducted with Spanish / English interpretation and settlement proceedings with self-represented employers. I conducted conferences that involved complex multi-party negotiations including the government, the employer, and the collective bargaining representative of the affected employees, the Union. Settlement proceedings sometimes involved more than one employer for example, on multi-employer construction worksites or on worksites where the affected employees, allegedly exposed to the hazard, were provided by a staffing agency. The overwhelming majority of the settlement proceedings I conducted resulted in an amicable resolution of the dispute between the parties. The amicable resolution obviated the need for litigation and provided a meaningful, forward-looking resolution enhancing workplace safety and health.

As a Settlement Judge, I provided preconference guidance and instruction to the parties regarding necessary preparation for the settlement negotiation. The parties were encouraged to learn the case facts and relevant law, exchange documents, and frankly assess the strengths and weaknesses of their case and the opposing party's case. The parties were encouraged to identify and assess their true needs and interests and consider the needs and interests of the opposing party. This preconference preparation enabled the parties to intelligently evaluate settlement options discussed during the conference.

At the settlement conference, I successfully employed facilitative mediation techniques, including active listening, identification of shared goals and interests, collaborative problem solving, practical and pragmatic negotiation techniques, and the consideration of creative settlement terms to address shared interests. Active participation was encouraged from all conference participants, each party's counsel, and each party's principal decision-maker holding full settlement authority.

I conducted settlement conferences regarding significant cases in a wide variety of industries under the regulatory jurisdiction of federal OSHA, including construction, vehicle glass manufacture, furniture manufacture, international paper manufacture, national retail stores, regional grocery stores, poultry processing plants, maritime terminals and docks, steel mills, steel fabrication shops, and chemical production plants, among others. Significant cases resolved by incorporating creative settlement terms to enhance workplace safety and health and ensure continued compliance with OSHA standards, in addition to terms regarding the agreed settlement penalty amount and citation item classification(s).

Hearing Judge.

I presided at and managed complex, adversarial hearings, ensuring development of a complete, relevant, hearing record. Hearing management and decision making required evidentiary rulings, factual findings, and legal conclusions regarding the issues presented. I conducted hearings pursuant to the Administrative Procedure Act and the Commission Procedural Rules, which required knowledge and application of the Federal Rules of Evidence.

I ruled on prehearing discovery, subpoena request, summary judgment and dismissal motions, issued show cause orders, protective orders, and resolved prehearing deposition evidentiary disputes. This experience required knowledge and application of the Federal Rules of Civil Procedure and the Commission Procedural Rules. Hearing docket management techniques included professional, respectful active listening, and collaborative, creative, resolution of scheduling, evidentiary, privilege, and discovery disputes.

I issued written decisions based on the hearing record and post hearing briefs. In certain cases, I also issued written decisions and final orders on prehearing motions, responses, and briefs. I issued decisions regarding the alleged violation of many varied OSHA standards, including standards regarding fall protection, excavations, electrical safety requirements, electric power transmission and distribution, steel erection, permit-required confined spaces, cranes and derricks, walking-working surfaces, hazardous materials, machinery and machine guarding, control of hazardous energy (lock out / tag out), powered industrial trucks, toxic and hazardous substances, lead, bloodborne pathogens, and alleged general duty clause violations, including worksite heat hazards and workplace violence. Among other issues, I adjudicated issues regarding single employer, independent contractor, employee status, and employer responsibility on multi-employer worksites.
