SUMMARY:

In 1995 Maryland began the process of welfare reform under a federally approved demonstration waiver. This demonstration waiver allowed us to use a five working day adverse action period for Temporary Cash Assistance and food stamps. We have lost the federal authority to continue to use a five working day adverse action period.

Adverse action is any action that reduces, suspends or terminates a customer's TCA or FS benefits. This AT describes only changes for providing customers with **timely notice** prior to taking an adverse action. Please refer to the TCA manual Chapter XIV, Section 1 and FS Manual Section 430 for further clarification of adverse action policy. Both manuals are accessible online from the DHR website (www.dhr.state.md.us) or the Family Investment Program (FIPNET) website on the Intranet.

ACTION REQUIRED:

Adverse action time for TCA and FS increases from 5 working days to 10 calendar days effective January 1, 2003. That means there must be at least 10 calendar days beginning the day after the notice is **mailed** to the customer to the date the adverse action becomes effective.

Examples

The case manager mails an adverse action notice on January 15, 2003. The 10-day adverse action period begins on the 16th and ends at the close of business on January 25. The adverse action affects eligibility February 1, 2003.

JANUARY 2003

The case manager mails an adverse action notice to a customer on January 24. The adverse action time period begins on the 25 and ends on February 3. The adverse action effects eligibility March 1.

Payment Accuracy

The increase in adverse action time for timely notice is effective January 1, 2003. CARES accounts for weekends and holidays in determining correct adverse action time. Case managers must take appropriate action on changes to ensure that adverse action is effective in the appropriate month.
