SUMMARY

This Information memo provides an updated contact list for TCA and FSP and MA.

Local departments must continue to count any months that a customer received Temporary Assistance to Needy Families (TANF, called TCA in Maryland) benefits in another state, as well as in Maryland, toward the 60 month time limit on all TCA cases.

We updated the contact list to include contact information for TANF, MA and FS so that case managers can contact other states when there is a question about duplicate participation or prior TANF months.

Remember: Case managers **cannot** request that an applicant provide a closing letter from another state prior to continuing to process the customer's application. It is our responsibility to make the call to verify case closure.

REMINDER

Case managers and supervisors are reminded to enter the customer's previous out-of-state addresses on the CARES "Previous Household Address" **PREV** screen by entering a "Y" in the "Previous Address in Last 2 Years" field on the CARES **ADDR** screen. Also, enter the dates of residence in the out-of-state address in the "from-to" fields on the **PREV** screen for each address listed.

Once the case has been processed, the supervisor must adjust the time limit counter (TLE) by adding to any existing count the number of months TANF benefits were received in the prior states in the "TCA Ctr" field on the **DEM2 01** screen. The supervisor should count all applicable months when adjusting the counter.

To change the TLE counter:

On the **AMEN** screen, type **R** (Interim/Hist Change)

Enter AU ID#

Press Enter

On the **DEM2 01** screen, **TCA Ctr** field change the number of countable months

On the **DONE** screen, press **ENTER** to commit data
