SUMMARY:

TCA applicants and recipients must verify the type of housing in which they live to prevent having the \$60 housing subsidy counted. We consider customers as living in subsidized housing when they do not verify housing type. We are revising the policy on housing verification requirements.

ACTION REQUIRED:

Effective immediately, TCA applicants and recipients do not have to **verify** the type of housing they live in unless it is questionable. The customer must still report this information. Code CARES according to the customer's statement about housing type. The \$60 deduction **still** applies if the customer indicates he or she resides in subsidized housing or the case manager has prior knowledge that the property is subsidized or other verification is received. Customers are still required to report information accurately and correctly. **Do not request verification of housing for TCA customers, unless it is questionable.**

Reminder:

For TCA cases in subsidized housing:

- **Caretaker Relative Child only** cases where the caretaker relative is not the parent and <u>not included in the grant</u>, do not deduct the \$60 from the TCA grant.
- Needy Caretaker Relative The caretaker relative is not the parent and <u>is</u> included in the grant, deduct the \$60 from the TCA grant.

- **Non-member TCA Parent** –where parent/s are in the home and not included in the grant, deduct the \$60 if residing in subsidized housing.
- **Customers living with someone else** and not paying rent directly to the landlord deduct the \$60, if residing in subsidized housing.

The TCA manual is being updated to reflect the change.

CARES PROCEDURES:

Correct CARES coding for the \$60 unearned income rent subsidy helps to ensure accurate payment of benefits. Code CARES for rent subsidy as follows:

Cases with parents and children included in the TCA assistance unit who declare they reside in subsidized housing are coded on the head of household's SHEL screen as follows:

- In the Subsidized Housing field, enter the appropriate housing code:
 - **P** Public Housing,
 - **R** FHMA 515, or
 - **S** Section 8.
- In the V field, enter the appropriate verification type:
 - LE Letter
 - LS Lease
 - MO Mortgage
 - **OT** Other (use when customer declares housing type)
 - **RE** Receipt
 - **RF** 1130 Rent Form
 - TE Telephone
