A meeting of the Law Faculty of the University of Maryland was held on the above date, at the office of the Dean, at three o'clock p.m., having been duly called "to consider some important matters connected with the preliminary examinations and the opening of the session."

Present: Messrs. John P. Poe, Dean; Joseph C. France, E.A. Poe, John C. Rose, Eli Frank; Judge Henry D. Harlan and Hon. Henry Stockbridge.

The hours for the Preliminary Examinations were fixed as follows:-

1. On September 24th, from eight to ten p.m., on English -- Spelling, Grammar, Composition and Literature; History -- United States and English.

2. On September 25th, from eight to ten p.m., on Mathematics -- Arithmetic; Science -- Political Economy, and Physics or Geography; Languages -- Latin or French -- at least two years' work.

Mr. E.A. Poe was selected to conduct the examination on Monday, September 24th, and Judge Henry Stockbridge, on Tuesday, September 25th.

It was moved to accept Certificates of Graduation from Deichmann's College-Preparatory School, Marston's University School for Boys, the Boys' Latin School, and Tome Institute, in lieu of examinations, and that any applications on certificates of graduation from other similar institutions, etc., be referred to the Dean and Secretary, with power. This motion was carried.

As to filling the Chair of Equity, a motion was made to invite Edwin G. Baetjer, Esq., to take the Chair of Equity and request him to reply as early as possible. Motion carried.

Sundry applications were presented and action thereon taken as endorsed therein.-

(a) Application of Mr. F. Dorsey Mitchell, who passed entrance examinations at Lehigh University, presenting Registrar's certificate to that effect. Referred to Dean and Secretary with power. Decided he should take examination.

(b) Application of Mr. R. Edelin Hamilton, who furnished certificate from President of Rock Hill College that he attended that institution for several years and gave satisfaction in his studies. Action taken as in case (a).

(c) Application of Mr. Julio E. Iguina, who passed Examinations at the Portorican Academy of Baltimore. Same action taken as in case (a).

Meeting held on above date at 3 p.m. at office of Dean, pursuant to notice.

Present: The Dean, E.A.Poe, Chesnut, Frank, Tiffany, Stockbridge, Gorter, Brantly, Rose and Harlan.

On motion, it was resolved that the Chair of Equity be offered to Mr. James P. Gorter, and that Mr. Albert C. Ritchie be selected to take the Chair of Commercial Law in the place of Mr. Gorter, transferred to the Chair of Equity.

Mr. Gorter declared his willingness to accept the Chair of Equity under these circumstances, and the motion was unanimously carried.

The Dean was directed to notify Mr. Ritchie of his election.

With reference to the request of the Intermediate Class for permission to introduce some athletic performances at the banquet to-night, it was resolved that it be declared the policy of the Faculty that no paid performers shall be brought into the Law Building to give exhibitions, and that no sparring or athletic exercises shall be permitted therein, and that the Dean be requested to take such steps as he may deem judicious in view of this declaration of policy.

The theses subjects for the session were selected as follows:

LIABILITY OF PRINCIPAL FOR MISTAKE OR FRAUD OF AGENT, as the subject for those contesting for the thesis prize.-

EXTRATERRITORIAL EFFECT OF DECREE OF DIVORCE, as the subject for those not contesting for the thesis prize.

On motion, it was resolved that General Jurisprudence and Legal Ethics be classified as a minor subject, and that it be given the value of 10 in the examinations at the close of the present term, and that Evidence and Damages be valued at 65, and International Law at 25, in said examinations.

It was also resolved that Jurisdiction and Procedure of the Federal Courts, Admiralty and Bankruptcy, be also classified as a minor subject, and that it be valued in the examinations at the close of the second term at 20, and that the value of Constitutional Law be reduced from 50 to 40, and the value of Equity be reduced from 50 to 40.

It was resolved that W.B.Deen be permitted to graduate, provided he passes all the subjects of the first half of the Senior year, to wit: Evidence and Damages, International Law and General Jurisprudence; and that he be not required to take the new subjects which have been added to the second term of the Senior year; he having already completed last year the course prescribed for the second term of the Senior year.

It was also resolved that William C. Schmeisser be permitted

September 20, '07.

The Law Faculty met in the new building, Lombard and Greene Streets, at 3:30 p.m. on the above date. Present, the Dean, and Messrs. Gorter, Frank, Ritchie, France, Tiffany, E.A.Poe, Rose, Chesnut and Harlan.

The Treasurer presented a statement of the contracts that had been made for alterations and additions to the law building, and for certain furniture, amounting to \$14,942.33, not including the commissions of the architects, and not including an extra to be adjusted, of between \$70 and \$80. He was authorized to take from the Contingent Fund such sum as may be necessary, over and above the proceeds from the bond issue, to pay these contracts and the architects' commissions.

Mr. Chesnut was authorized to procure, at the lowest price practicable, a new set of Maryland Reports, from the 1st Maryland down, and also to replace such volumes of the Brantly edition of the earlier reports as may be missing.- It was also resolved to have the old set of the Maryland Reports retained and rebound.- This expense to be defrayed out of the Contingent Fund.

The estimate of Richard Wolff for the covering of the tables at the Law School, and otherwise repairing them, was accepted. Amount of estimate, \$36.

The offer of the Art Metal Construction Company to equip the library with metal shelving, was respectfully declined, the Faculty being of the opinion that the cases now in use are suitable and sufficient for the library at present.

The Secretary was instructed to write to the representative of the publishers of the Encyclopaedia of Evidence that the work is not desired for the Law School library at this time.

The application of Mr. L.C. Weaver, for an advertisement of the Law School, to be inserted in the Souvenir Book of Baltimore, a publication incidental to the "Home Coming Week" in October, was declined.

The applications of Wm. Curran, Louis Ashman, Wm. McHugh and D. S. Kaufman, to be appointed Librarians, was referred to the Library Committee, consisting of Messrs. France and Chesnut, with authority to select the Librarians for the Session of 1907-8, and to provide rules for the administration and government of the Library.

The application of Mr. Samuel E. Thompson, to be permitted to take all three classes in one year, and to graduate at the end of that year, he being a graduate of Harvard and having completed one year in the Harvard Law School, was granted; Mr. Thompson to be informed of the conflict in the hours of lectures, and that the fees for taking the course in this way will be \$90 per term, and \$5 library fee for the session.

The application of Mr. Henry Kaufman, to be exempt from taking the preliminary examination, he having had one year at the Baltimore City College, was refused.

The application of Mr. J.O. Herrmann (a student at the Baltimore City College for three years) to be exempt from the preliminary examination, was granted upon the certificate which he presented.

The application of Mr. E.H. Wooten and that of Mr. G.C. Feurst, to be exempt from taking the preliminary examination, on certificates presented from the Western Maryland College, were also granted.

study at the Law School as may seem most advisable.

There were present the following: Harlan, <sup>Dean</sup> Stockbridge, Gorter, France, Poe, Tiffany, Ritchie and Frank. The Committee appointed to make recommendations with respect to the filling of the vacancy in the Board of Instruction caused by the death of Mr. John P. Poe, and also to make recommendations as to a readjustment of the schedule, if found desirable, submitted the following report through Mr. Joseph C. France, Chairman.

Mr. Poe had been giving 105 lectures in the various courses conducted by him during each school year. Fifty-two of these lectures had been devoted to the subject of Evidence. The Committee regards this as too many lectures for this subject and recommends a course of two hours a week extending through one-half the year, and this to include four lectures on Damages. The Committee recommends that Judge James P. Gorter be asked to take the course as thus outlined.

The committee further <sup>recommends</sup> ~~reported~~ that the subject of Torts be dissociated from the course in Pleading and that it be made a separate course, consisting of sixteen lectures.

That the courses in Pleading and in Practice be consolidated and together to comprise 32 lectures. The Committee further suggested that as this arrangement would not take up all the 105 hours that had been assigned to Mr. Poe, it would be well to consider the propriety of employing non-resident lecturers to deliver special courses of lectures to be hereafter arranged. The report of the Committee was adopted and thereupon

the following elections were made:

Judge James P. Gorter was elected to the chair of Evidence, Mr. Joseph C. France to the chair of Pleading and Practice, and Mr. William L. Marbury to the chair of Torts. Judge Gorter accepted his election, Mr. France did likewise, upon condition that he be relieved from the subject of Elementary Law and General Jurisprudence, which condition was assented to and the Dean was requested to communicate to Mr. Marbury the fact of his election.

The meeting thereupon adjourned.



In many things John Prentiss Poe did much and was much. Others have told what he was and what he did as a lawyer, as a citizen and as a servant of the people. We would speak as to what he was to the School of Law of the University of Maryland and of what he did in it and for it. In very truth there is such a school because he felt that there was need of it and because so feeling he caused to be opened doors which had been closed for *about four* years. He made others see how much such a school would do for the Bench and Bar of Maryland and through the Bench and Bar for all the people of the State who seek justice and who would do justice. We would take nothing from the meed of praise due to many able and earnest men who in the last forty years have worked with him as instructors in that school. Some of them went before him to join the great majority. Others, though still with us, have been forced by other calls on their time and strength to give up the work of teaching. And yet however eminent and earnest some of these men were, none of them ever gave of themselves to the school even for a few years what he gave of himself through four decades. No professional or public calls of any kind ever came between him and his teaching in that school. No one of all who have been part of it were ever so much interested in it as was he. None made themselves personally more loved by the students who in its halls took their lessons in the law. Whatever else in the years that are to come may be done for the school by others, none can ever fill the place in it of him who was its founder and for forty years its most zealous and active teacher.



It was deemed impracticable at this time to adopt Mr. A. H. Fisher's suggestion that the Faculty establish a law review, in view of a scheme for publication of a Md. Law Journal by a local publisher

6. The Practice Court, as here conducted, affords real training in the preparation and trial of cases, and thoroughly prepares the student for the practice of his profession.


7. The Faculty and students maintain close personal relations, thus affording facility for questioning and discussion.

The rooms are large, well lighted and ventilated, high ceilinged, and furnished with modern conveniences. The Library contains more than two thousand carefully selected law books.


